- 1. Welcome, introductions and declarations of interest
- 1.1 The Chair welcomed members and officials to the Quality Assurance Committee meeting.

#### 3. EQA Consultation

3.1 The Committee noted that the Institute had published a consultation on the future delivery of external quality assurance. The Institute was undertaking external engagement with the sector in relation to EQA. This consultation was launched on 27 February 2020, however, was extended by 6 weeks and will now close on Thursday 21 May 2020.

4.1 The Committee noted that the Quality and Assessment team is working to fully on-board remaining EQAPs on to Qualitas.

# 5 Status updates on EQA providers

- 5.1 Members were informed that the Institute has now 18 EQAPs using Qualitas and uploading their respective reports on the digital portal.
- 5.2 The Committee was asked to consider the findings contained in the reports which the Institute (via Open Awards) and other EQA providers produce.
- 5.3 It was agreed that in future the Assessment and Quality team will list all the EQA reports that come though on Qualitas alongside their designated RAGrating. In additional more detail will be provided around actions through summary boxes.
- 5.4 It was noted that there has been an impact on the apprenticeship landscape due to Coronavirus and the Institute is exploring potential adjustments to the delivery of EPA.

6.1 The Committee considered assessment submissions for T Levels at Wave 1 Milestone 3 and Wave 2 Milestone 1.



## 7. Forward Look

7.1 The Committee heard that given the on-going situation with respect to the coronavirus epidemic, the focus of the Assessment and Quality team will remain in supporting flexibilities and discretions and ensure assessments are able to continue.
