#### Welcome and Introductions/declarations of interest

- 1. Antony Jenkins (The Chair) welcomed Board members and participating officials to the meeting.
- 2. The Chair asked Board members whether they had any declarations of interest to make. #### Minutes, actions from the last meeting

3. The Board approved the minutes from the last meeting, with no further comments.

#### Covid-19: Risks and Quality Audit

- 4. RN presented an update on the Institute's COVID response, including programme performance, the formation of a Risk Mitigation Action Group, support provided across the skills landscape, and the Institute's risk mitigation, in addition to ongoing activity to support Institute officials to continue to effectively deliver the Institute's programme of work.
- 5. PM provided a Department for Education perspective on programme performance.
- 6. The Chair thanked the Institute officials for their continued work in this space.

# **Organisational Redesign Update**

- 7. LR provided an overview of the Institute's proposed organisational redesign, to reflect the change in the Institute's role across the skills landscape, including the proposed timeframe of the process.
- 8. Board members suggested that the proposal should be developed into an operating model for the Institute.
- 9. The Chair noted the Board's appreciation for the integration of strategy into the proposal and the clarity of the proposal itself.

## **Performance Reporting Update**

10. RN noted routine changes to the Institute's performance reporting dashboards to reflect the publication of the Strategic Guidance for the Institute in July. The Board noted and approved the changes

11.PM provided an update on progress of the FE White Paper. PM also noted the prime minister's speech (29/9) in the context of the skills landscape.

#### T Level Update

12. RN updated the board on the progress of the T Level programme, covering waves 1,2,3 and 4.

13. The Board approved refinements to the technical qualification approvals governance process.

14. The board approved measures to improve route panel capacity in the short term and to support efforts to continue exploring long-term methods of employer engagement

# **Apprentice Panel Survey Update**

- 15. Three apprentices, Joel, Louis, and Amelia, provided an overview of the Apprentice Panel survey, which ran from 30th April until 12th June 2020.
- 16. The Board noted the significant response to the survey, the makeup of respondents and their attitudes towards the key components of an apprenticeship.
- 17. The Board noted the six recommendations of the Apprentice Panel.
- 18. The Board offered additional support to panel representatives in their future endeavours
- 19. The Board expressed thanks to the representatives for their presentation and to all those on the Apprentice Panel who have worked hard to produce the survey.

- 20. The Board the board revisited the approach to the inclusion of degrees within apprenticeships which was discussed in more detail at the previous board meeting.
- 21. The Chair indicated support for another ESFA-Institute board to board meeting.
